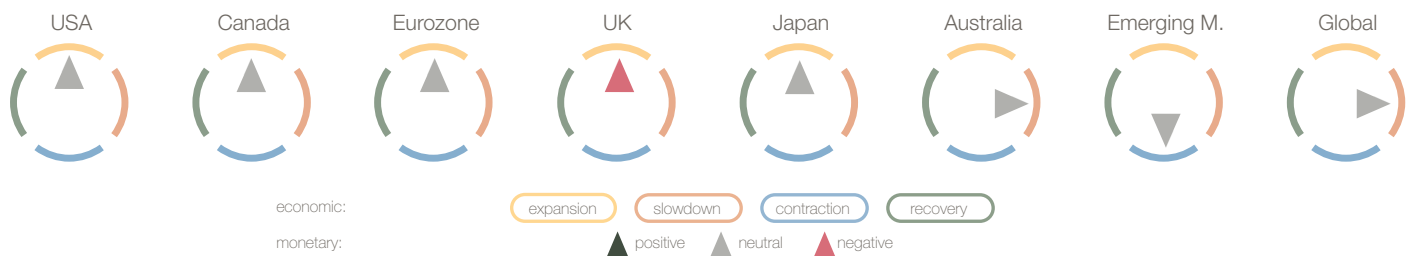
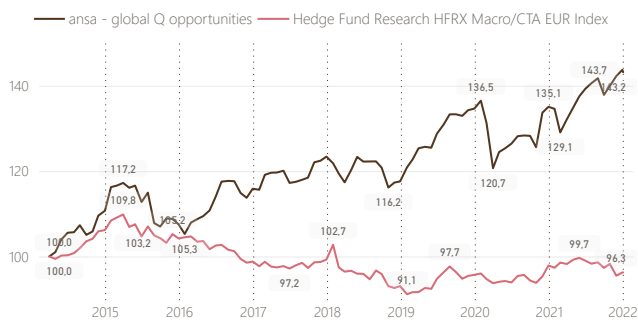

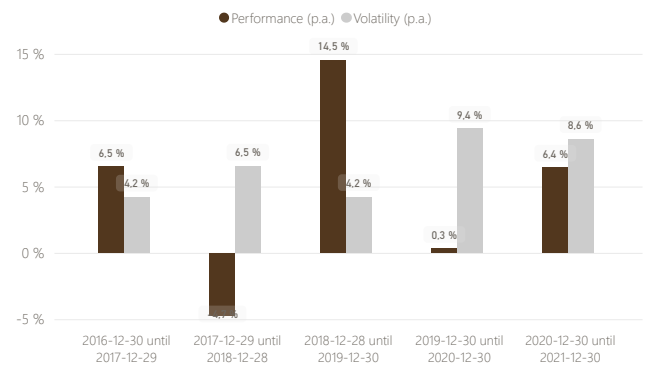
ansa - macro regimes

I-shareclass, Apr-Sep 2014 P-Shareclass. Source: Bloomberg

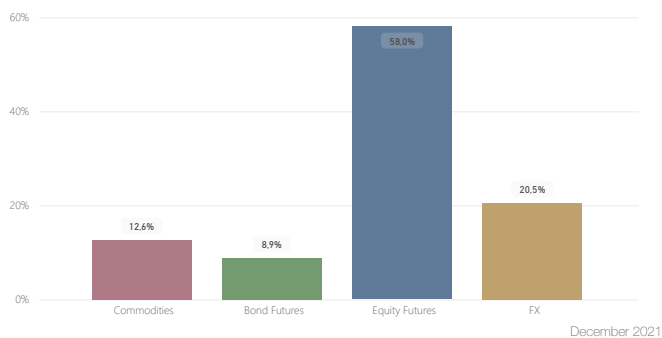

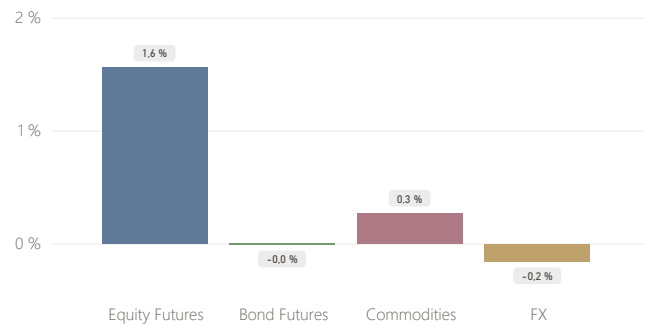

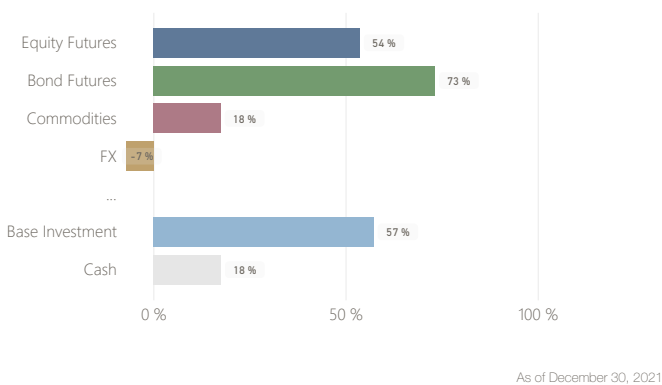
average risk contributions



performance contributions



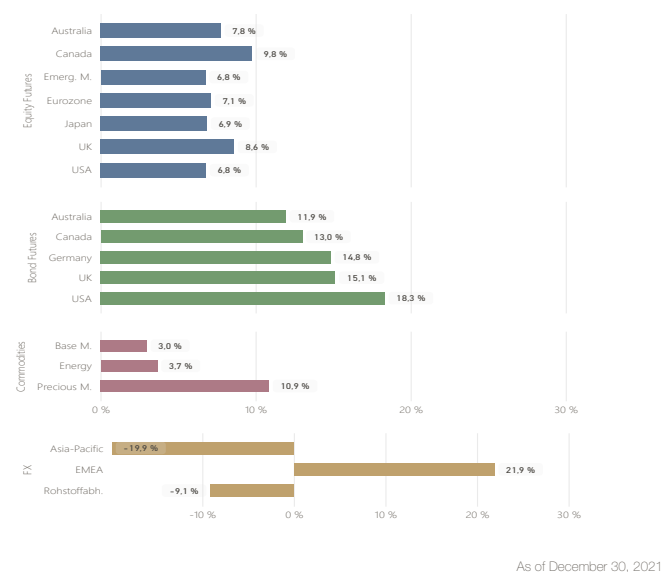
